Response:

Tier I (At Administrative Level)

The College believes in a system of freedom to operate independently, so it follows a separate committee system at every level through the participation of teachers in the committees for the purpose of separation. Its administrative and management obligations towards the academic events held in the institution. According to the self study report of the college "Goel Institute of Higher Studies Mahavidyala" believes that this type of arrangement displays the democratic view and each member of the committee of college do their best for smooth functioning of the college and they also knows their responsibilities regarding the college. This system encourages, motivates and maintains power relationship towards the recognition of trust, responsibility, sharing and interdependence.

Tier II (At Faculty Level)

Teachers committee is implied in planning and decision-making regarding curricular work, teaching method, and use of resources. The leadership of the college is decentralized in nature in which teachers committees supervising and participating in board of management meetings.
